

**MINOR RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT
(READ CAREFULLY BEFORE SIGNING)**

IN CONSIDERATION of allowing the below MINOR participant to compete, officiate, observe, work for, or participate in any way in the above event and/or activities ("Event(s)") and/or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials or permission to enter or any area to which admission by the general public is restricted or prohibited, including but not limited to the competition area), the undersigned, as parent/guardian, representative, heirs and next of kin of the MINOR, hereby agrees:

1. THE MINOR AND PARENT OR GUARDIAN hereby acknowledge that they have inspected the RESTRICTED AREA they believe something is unsafe, and that the MINOR may come in contact with during the rally.
2. THE MINOR AND PARENT OR GUARDIAN (as identified below) or otherwise, while in the RESTRICTED AREA, recognize and understand that there are risks of injury or death. Further, the risks and dangers of participating in the RESTRICTED AREA are assumed by the MINOR.
3. THE MINOR AND PARENT OR GUARDIAN hereby release, defend, hold harmless, and indemnify the Event Operator, operators, track owner, officials, car owners, and their officers, agents, and employees, and their heirs, and next of kin for any and all claims, damages, or injury to the parent/guardian or MINOR or damage to property.
4. THE PARENT AND/OR GUARDIAN hereby release, defend, hold harmless, and indemnify the Event Operator, operators, track owner, officials, car owners, and their officers, agents, and employees, and their heirs, and next of kin for any and all claims, damages, or injury to the parent/guardian or MINOR or damage to property.
5. HEREBY agrees that this Release and Waiver of Liability and Indemnity Agreement is intended to be as broad as possible and that the balance shall, notwithstanding anything to the contrary, be construed in favor of the Event Operator.

Step 1 – Parent #1 completes all **yellow** areas.

Step 1a – If “sole legal custody” box is checked, parent #1 *must* initial.

Step 2 – Parent #2 completes all **blue** areas.

Step 3 – Registrar completes all **green** areas *appropriately*.

- One parent signature = event specific.
- Both parents signatures (or sole custody box is checked *and* initialed) = may be event specific *or* “All Events/All Dates.”

The MINOR's Event participation constitutes a release of the Event Operator from liability for any time in the RESTRICTED AREA. The undersigned hereby agrees that the MINOR will withdraw from participation in the Event at any time or areas which the MINOR or the Event Operator chooses.

I/WE FURTHER ACKNOWLEDGE THAT FAILURE TO WITNESS OR NOTARIZE THIS AGREEMENT SHALL NOT AFFECT ITS VALIDITY.
